Police Scotland came into effect on 1st April 2013 and with that a number of internal changes took place. Aberdeen City Division has worked hard to ensure that throughout this period of change the level of service provided to members of the public and the communities in Aberdeen City has remained unaffected.

One of our main drivers is the delivery of better targeted local policing; improved access to local policing; improvements to the quality of policing service; and, a policing service which is more sustainable and cost-effective. Our focus is on keeping people safe and local policing is the foundation stone on which Police Scotland is based.

With this in mind we would like to ask you, the panel, a couple of questions about our current Policing Priorities and how safe you feel you are in your City. We currently have seven policing priorities, which include:
