Influence and sense of control – lowest ranking across the 14 place standard themes both city wide and localities. Awareness of opportunities to get involved in decision making and feedback for ALL – potential gap.	
		The group discussed the findings which were not surprising considering the public's reaction to recent events such as library closures and consultation taking place after the decision was already made. Martin described the major health benefits of involving people in decisions and increasing their feeling of influence of and sense of control and why community empowerment is a major driver in our approach to prevention and early intervention. Elaine stated that the results are very reflective of what we heard at the community gathering event earlier this year. Trust and honesty essential. E.g. communities only getting to hear part of the budget.

			Bea noted that communities say they don't have enough opportunities to share their views but we do hundreds of consultations. It is not about increasing the amount of consultations but the ways we do them. People don't want to fill their time with focus groups and surveys. Conceptualise them in a different way. Get creative. Elaine observed that if we have different relationships with communities we won't need to do 144 consultations a year. People can be aware of consultations but if they don't have trust and belief that by participating it will make a difference then there is very little point. Culture change required. Elaine gave an update on work Luan Grugeon is doing for NHSG over the next six months to review the effectiveness of their community engagement mechanisms. Dave highlighted the need for more accountability for better community engagement as we can't afford poor engagement. Maria agreed that there needs to be more effort to do good community engagement. The number of people engaging in the process is a key indicator which decision makers want to see but participation levels don't' always tell the full story about how effective the engagement process has been.
